Thanks to both the WIN interpreter network and OnTrack's WNC's Spanish-speaking staff, Marisol received information and guidance to dispute errors and negative items on her credit report, and manage balances and payments to build her credit score. She also received referrals to rental housing options, an evaluation of her home affordability range, and an action plan to increase her home-buying power. Marisol now feels she has the tools to achieve her goals and looks forward to the day she will have her own home.

After a cascade of bad fortune where his truck broke down, and his rent money was stolen during a break-in, Evan was behind on paying his rent. Evan had lived in his rental home for seven years and had always been current on his rent and paid on time.

With the string of bad luck he experienced, he did not have the ability to make his payments and received a 10-day eviction notice to vacate the home. Evan called Pisgah Legal Services for assistance and Attorney Adrianna Gomez quickly went to work negotiating with the landlord and was able to arrange a settlement agreement for the eviction to be dismissed, allowing Evan to remain in the home.
